Master's Program Application Checklist

Timeline for students to apply: Apply before their second semester of their Preliminary Credential program.

1. Before each deadline (Fall: March 15th and Spring: October 15th), students must submit:

- 2. Once all items are submitted and received, the Special Education Admissions office will schedule the student's **interview**, **which includes**; a **Master's program overview and time to complete a writing sample. The writing sample will be based upon an article emailed to you.**
- 3. An admissions decision will be made and the Admissions Assistant will send you an admit or denial letter. **Students will also be informed of SPED 501** information if they are admitted.

Requirements for program:

- 1. Candidates must have a minimum **3.0 GPA in their last 60 units** to be eligible to apply.
- 2. There are NO rollover applications. If you do not submit all deadline documents or interview packet (which is your complete application), you will not be able to rollover any documents to the next semester. If you wish to reapply, you must submit ALL new documentation.
- 3. Candidates may only apply TWICE. If you have been denied and choose to reapply, you are required to take two of the three Reading courses, READING 201 or 202 and 290 and you must receive a letter grade of "A" in the courses.
- 4. Past program history and dispositions are considered when students apply.
- 4. Candidates must score a minimum 80% out of 100% to be admitted to the MSE program, but you must pass the writing part to be admitted to the program (see rubric). http://ed.fullerton.edu/sped/ resources/pdfs/written-interview-rubric-masters-program.pdf.

Interview Procedure:

- 1. Admission Process Orientation
- 2. Arrive 5 minutes prior to scheduled interview.
- 3. Allow 80 minutes for the written interview.
- 4. The department Graduate Committee will make an admission decision and candidates will be notified through an e-letter from the SPED Admissions office within a month.
