THE CENTER FOR CAREERS IN TEACHING If you are meeting Subject Matter through CSET:

- You may choose either the *Multiple Subject CSET* (3 subtests) <u>OR</u> Single Subject CSET (varying numbers of subtests depending on the subject area).
- Must pass ALL CSET subtests within the subject area before applying to the program.

NOTE: Even if you sent the results to CSUF, you **STILL** must **upload** the results to the Cal **X** State Apply application, as this is the only way the SPED department will be able to review your results.




